COURSE OUTLINES

BIBLICAL STUDIES

FOUNDATIONAL LEVEL

Introduction to the Old Testament

BD111B/ BB111B/ BB411B

This course unit aims to provide an historical, literary, theological and thematic introduction to the Old Testament.

ADVANCED LEVEL

Hermeneutics

BD203B/ BB203B/ BB403B This unit has prerequisites

This course unit aims to introduce students to the history, goals and general principles of biblical interpretation and to those that are specific to the various literary genres in the Old and New Testaments.

Johannine Literature

BD268B/ BB368B/BB568B This unit has prerequisites

This course unit examines the literary forms and theological content of the New Testament Literature associated with John, with due consideration of their historical, cultural and religious settings/contexts.

CHURCH HISTORY

FOUNDATIONAL LEVEL

Early & Medieval Church History

HD119B/HS119B/HS419B

This course unit allows the student to explore the history of the church from its emergence to 1500 CE set against the broader context of society and culture.

MISSIOLOGY

Cultural Anthropology

MS121B/ MS421B

This course unit aims to introduce students to anthropological principles and their application to various contexts.

PASTORAL THEOLOGY AND PRACTICE

Principles of Christian Leadership

PD261B/PT262B/PT462B

This course unit aims to provide insight into the nature, scope and challenge of leadership in the 21st century and to help students identify and apply Christian principles to the leadership task.

Pastoral Theology

COURSE OUTLINES

BIBLICAL STUDIES

FOUNDATIONAL LEVEL

Introduction to the New Testament

BD150B/BB250B/BB450B

This course unit aims to introduce students to the critical study of the New Testament, its literary forms, historical and cultural contexts and theological themes. It seeks to provide a solid foundation for further biblical and theological study.

ADVANCED LEVEL

Prophetic Literature

BD231B/BB331B/BB531B This unit has prerequisites

This course unit examines the literary forms and theological content of Israel's Prophetic Books, with due consideration of their historical, cultural and religious settings/contexts.

Issues in Genesis 1-3

PT594B/PT597 This unit has prerequisites

This course unit enables students to pursue a particular issue or issues in Genesis 1-3 to deepen their understanding and to develop their skills of research.

CHURCH HISTORY

FOUNDATIONAL LEVEL

The Church: Reformation to Present

HD159B/HS259B/HS459B

This course unit allows students to explore in detail the history of the church, its doctrine, practice, and worship, from the Reformation to the present.

ADVANCED LEVEL

History of Christianity in Australia

HD267B/HS267B

This course unit aims to examine the history of the Christian churches in Australia, from their colonial beginnings until the present time.

LITURGICAL STUDIES

FOUNDATIONAL LEVEL

Introduction to Christian Worship

LD200B/LS100B/LS400B

This course unit introduces students to the study of liturgy within the evangelical tradition.

ADVANCED LEVEL

Preaching 1

LD220B/LS220B/LS420B This unit has prerequisites

This course unit seeks to establish a theology of preaching that provides an adequate theoretical foundation to preaching practice and introduces students to the foundational skills needed for the preparation and delivery of expository sermons.

Communicating the Doctrine of Sanctification

LD223B/LS323B/LS323B This unit has prerequisites

This course unit at advanced level aims to apply the Wesleyan doctrine of sanctification to the specific ministerial context of communication as preaching and teaching.

MISSIOLOGY

FOUNDATIONAL LEVEL

Church and Australian/New Zealand Societies

MD161B/MS161B/MS461B

This course unit aims to introduce students to the ways in which church and society in Australia/New Zealand contexts relate this providing an essential foundation for pastoral practice.

ADVANCED LEVEL

Evangelism

MD208B/MS208B/MS408B This unit has prerequisites
This course unit is an examination of the history, theology and practice of evangelism and its application to contemporary society.

THEOLOGY

ADVANCED LEVEL

The Triune God

TD234B/TH334B/TH534B This unit has prerequisites

This course unit aims to study the nature, attributes and creative work of the Triune God, made known to us through general and special revelation.

PASTORAL THEOLOGY AND PRACTICE

ADVANCED LEVEL

Supervised Ministry 1

PD282B/PT282B/PT482B This unit has prerequisites

This course unit incorporates learning experiences at a practical level as well as giving opportunity to reflect on both the practice and theory of ministry. This reflection occurs with an appointed supervisor as well as the formal classroom situation. The mentoring would be with experienced ordained pastors or those in recognised specialist ministries.

Supervised Ministry 2

PD382B/PT382B/PT582B This unit has prerequisites

Building upon the experience of the Supervisory Ministry 1, this course seeks to increase the student's confidence and expertise in the practice of public ministries of the church. The process should equip the student to develop skills in order to be able to exercise their own mentoring ministry.
